Note that the pre-registration fee covers the first two sessions of the GNT competition. On site, your team will need to provide an additional \$48.00 to the site monitor for each session, if any, beyond the first two.

Your registration and deposit must be received by April 4, 2015 (Championship & Flight B) and April 11, 2015 (Flights A & C). Send form and payment early to avoid postal delays. (If a last minute entry, you may give your entry and deposit check to a local D20 Board Member, but still by the deadlines above. Changes in team membership will be allowed if submitted at least 48 hours in advance of the contest.

By entering this event, all participants agree to abide by both the ACBL and District 20 Conditions of Contest, available on the District 20 Website at [http://web2.acbl20.org/NA\\_Events/GNT.html](http://web2.acbl20.org/NA_Events/GNT.html).

Friday evening session starts at 6:30 PM PDT; morning sessions will start at 11:00 AM Pacific Daylight Time (8:00 AM in HI, noon in ID). Second sessions TBA. The format depends on the number of teams entered, but the plan is for two qualifying sessions and two final sessions in the Championship and "A" Flights. Flights "B" and "C" will conduct a one-day, two-session Round-Robin to determine a winner.
