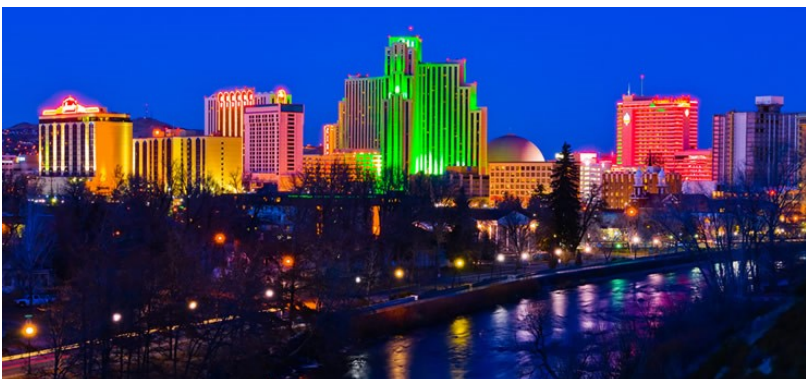

Gold was discovered in nearby Virginia City in 1850. Silver discovered in 1859, leading to a mining rush. Early pioneers began settling the Truckee Valley in the 1850s.

Truckee River and Truckee County were named after a Shoshone / Paiute medicine chief. Truckee met with the Lewis and Clark expedition in 1805. He was friendly with white settlers including explorer John Fremont. He died in 1860, possibly from a tarantula bite.
